Sub: Annual Plan 2011-12 – Communication of
Approved outlays – Calling for scheme-wise/
Budgetary Details - Regarding

The department/sector-wise approved outlay for the Annual Plan 2011-12 along with details of special programmes are sent herewith in Annex. **The Heads of Departments dealing with Plan are requested to furnish the Budgetary details to Budget Officer, Finance Department latest by 11.08.2011 endorsing a copy of the same to this department.** While furnishing the Budgetary details, the instructions contained in the Finance Department's Note No.00075/2010/11/F1(B) dated 02.08.2011 may be strictly followed; wherein the grants released to Public Sector Undertakings/Society/Co-operative Institutions, Local Bodies have to be shown in two different object head "36 - Grants-in-Aid - Salaries" and "31 - Grants-in-Aid - Other Purposes". The Administrative Departments may please ensure that no share capital assistance is provided to Public Sector Undertakings / Societies / Co-operative Institutions which receive Grant in Aid.

2. Heads of Departments are also requested to furnish **the scheme-wise details for the approved outlays to this department as per the scheme-wise codings latest by 11.08.2011.**

3. In respect of Building programmes, the departments may ensure outlay only for those schemes for which administrative approval and expenditure sanctions have already been obtained and not for any new programmes/works. This may please be done in consultation with Chief Engineer, PWD. Since we have only 8 months left for the current financial year, adequate care may be taken to see that only the required minimum of outlay is allocated to building programmes so that the committed liability under the non-building programmes could be provided funds adequately.

4. All the Heads of Departments/ Offices implementing plan programmes may strictly ensure that the plan allocation to the outlying regions is allocated in proportion to the population to the extent possible in the respective region(s) excluding the centralised purchase, if any, made in Headquarters. Allocation of funds for major projects of respective region may please be taken care by each department.

5. Department /Sector-wise SCSP allocation has been made to all the relevant departments in consultation with Adi Dravidar Welfare department, being the nodal department for SCSP programmes. Hence, the concerned departments may implement the SCSP programmes in accordance with the guidelines issued by the Ministry of Social Justice and Empowerment, GOI / Adi Dravidar Welfare department in the U.T. of Puducherry with the approval of Minister for Welfare.
