2. The functions of the State Planning Board will be:

- i) To advise the Government on the formulation of Development Plan / Schemes for the Territory.
- ii) To review the implementation of the Development Plan / Schemes.
- iii) To advise the Government on any matters pertaining to economic development and policies and
- iv) To find avenues to augment resources to meet the needs of development planning.


3. The State Planning Board will be a non-statutory Advisory Body. The non-official members of the Board are entitled to draw TA/DA for attending the meeting of the Board as applicable to Government officials drawing Grade pay of ₹ 7600/-.

4. The Board will meet twice in a year i.e. one meeting for taking stock of resource position to meet the plan requirements and another one for approving the Draft Plan proposals.

5. The expenditure will be met under the head "3451-Secretariat Economic Services - 090-Secretariat - 090(04) - Strengthening of State Planning Machinery - 090(04)(01) - Puducherry Region (Plan)".
